# MINUTES OF THE PARISH COUNCIL MEETING HELD ON TUESDAY THE 15TH of JULY 2025 FROM 19.00 AT JEPHSON HALL

To approve the Annual Parish Council meeting minutes from the 20th of May 2025 proposed ND, seconded RW and unanimously accepted by all present at that meeting.

#### 5. MATTERS ARISING:

- a. Speedwatch Cllr Dolby had agreed to take this on with assistance from Cllr Kirk. Cllrs R Dyble, G. Roberts and R. White are interested in taking part with Cllr White offering to help with the set up.
- b. Solar power for street lighting Clerk had a quote from Westcotec for £4500 ex VAT for each light. Costs high due to UK Power Networks charges. It was agreed by all that we cannot pursue this further. Clerk to check with the SSE brokers on the out of contract situation and when credits will be in our bank account. ACTION: Clerk c. Memorial names ND has a volunteer to research the names and this is on going. Cllr Kirk advised that he has a new grant available for village events and this may come under the remit as not a PC event. Local sponsorship could also be followed up.
- **6. CHAIRMANS REPORT:** SAM speed report Millenium Garden, Sutton Road heading east: 1.6.25 to 22.6.25 total vehicles 8,275, average speed 85<sup>th</sup> % =41.5mph, overall average speed = 34.9mph. % over the limit = 18.4% with average speed of 44.6mph. Maximum speed of 75mph on the 6.6.25 at 18:30 hrs.

Neighbourhood Plan update – at the Reg 16 stage with the independent examiner raising the Statement of modification missing from the Reg 14 survey information. This document was not sent to the Parish Council for inclusion on the website and is in the process of being redone which ends on the 15<sup>th</sup> of August.

The defibrillator had been taken out but not used.

**CLERKS REPORT:** The SSE issue continues as the invoices they raise are still not addressed correctly to Walpole Cross Keys PC and the monies owed to us are still outstanding. GC asked why the payment was made in June which was due to SSE still supplying us and Clerk not wanting the PC to have collection notice.

Clerks networking raising concerns that the possible changes from devolution and local government reorganisation will lead to more work.

The government are looking at major changes to planning to make applications quicker and easier to get through.

The National Grid project to Walpole continues and the clerk will keep the council updated.
